

Terms of Use

MRHV, provided by Go Green Properties, Inc, is a website dedicated to providing data to evaluate real home values and related real estate evaluations (Services). By using myrealhomevalue.com (MRHV), you agree to be bound by the following terms of use ("Terms of Use").

1. Personal Use. You agree to use the Services for your personal use. Your commercial use is limited to transactions done on your own behalf. Real estate and lending professionals may provide information to consumers via Services where authorized and may take actions on your behalf as a consumer client by utilizing Services to help determine a properties' real home value (RHV).
